**A RESOLUTION COMMITTING THE TOWN OF IRMO TO PROVIDING
A LOCAL MATCH FOR A MUNICIPAL ASSOCIATION OF SOUTH CAROLINA
BIG IDEA GRANT AND FOLLOWING ITS PROCUREMENT POLICY WHEN
SECURING SERVICES AND PRODUCTS WITH GRANT FUNDS**

BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF IRMO, here assembled on this 25th day of September, 2025, that the Town Council hereby commits to provide a local match of at least \$5,000. which equals the minimum 5% local match required by the Municipal Association of South Carolina, to support the Town's application for a Big Idea Grant in the amount of \$100,000. These grant and local matching funds will be used for Moore Park: A Sensory Celebration, an array of upgrades to the Moore Park Playgrounds to engage the senses of the playground's visitors.

BE IT FURTHER RESOLVED that the Council will follow its procurement policy adopted in accordance with SC Code of Laws Section 11-35-50 when securing all services and products purchased with funds awarded from a Big Idea Grant.

This resolution is made in regard to the submission of an application for Big Idea Grant funds to the Municipal Association of South Carolina on or before the application deadline of September 26, 2025.
